### Three Banner & Witcoff Attorneys Named To Key Positions Of Intellectual Property Law Section, American Bar Association

*Chicago, IL - August 4, 2001.* Three attorneys from the Intellectual Property law firm of Banner & Witcoff were named to key positions of the Intellectual Property Law Section of the American Bar Association (ABA).
