Darrell is an attorney at Banner Witcoff, and the past president of the D.C. Bar. Darrell advised a Fortune 500 company on an anti-counterfeiting project which included opinion analysis and scope and patent identification in a global anti-counterfeiting action using design/registrations. Darrell has advised clients on intellectual property matters in multi-million dollar venture capital transactions. He has successfully represented clients and obtained U.S. utility and design patents through the U.S. Patent and Trademark Office (USPTO), and the firm successfully enforced the patents to protect the core businesses of clients. He has successfully represented clients before the USPTO Patent Trial and Appeal Board (PTAB). Darrell earned a Bachelors of Science in Engineering Science and Mechanics in 1987 and his Masters of Business Administration from the Virginia Polytechnic Institute and State University in 1994 with a concentration in corporate finance and management science. He earned his Juris Doctor degree, with honors, in 2000 from The George Washington University, where he also served as an editor on the student editorial board of the ABA Public Contract Law Journal. He had an article published in the journal concerning information technology in the Federal Government.

Darrell is the former Chair of the District of Columbia Bar's Council on Sections. He also served as Vice-chair of, Division IV of ABA Section of Intellectual Property Law. Darrell is registered to practice before the United States Patent and Trademark Office and is a member of the National Bar Association concentrating on intellectual property law. He is also a Fellow of the American Bar Foundation, the premier U.S. socio-legal research institute.

Darrell completed a four-year term on the Industrial Advisory Council at the College of Engineering at Virginia Tech. In this capacity he assisted with the recruitment, retention, and development of students in engineering, focusing on under-represented students from diverse backgrounds.

Darrell is an adjunct professor at The George Washington University Law School teaching classes in design law. Darrell previously lectured on patent law at Howard University Law School. Darrell is a contributing author to the Thomson Reuters published book, Navigating Fashion Law: Leading Lawyers on Exploring the Trends, Cases, and Strategies of Fashion Law, in which he authored the section "The Tools for Protecting Fashion Law Clients."
