Kirk began his legal career in Tokyo, and now regularly advises on U.S., Japanese, Korean, Chinese, and European IP matters. Kirk's practice involves a wide range of technologies, from cutting-edge artificial intelligence models and self-driving cars to video games, fashion, and children's toys. For example, Kirk has worked on major patent prosecution and enforcement disputes involving machine learning, natural language processing, networking and cybersecurity, cellular communications, virtual reality, self-driving cars, biotechnology, medical devices, military weapons systems, cryptocurrency, aerospace flight systems, video encoding, oil and gas engineering, optoelectronics, data storage, and more.
