Tom focuses his practice on litigating and trying complex intellectual property matters. Tom has successfully represented clients in all phases of intellectual property infringement lawsuits in district courts throughout the country, including trial, preliminary injunction hearings, Markman hearings and other pre-trial hearings, discovery, and pre- and post-trial motions.

Tom also has an active practice before the Patent Trial and Appeal Board (PTAB), including successfully representing clients in trials in inter partes review proceedings in the electrical and computer hardware/software arts. Tom also has experience successfully handling and arguing appeals before the United States Court of Appeals for the Federal Circuit.

Since joining the firm in 1992, Tom has successfully represented both plaintiffs and defendants as lead and co-counsel in litigation involving diverse subjects such as computer software, website technology, contact lenses, athletic footwear, consumer electronics products, digital watermarking, exercise monitoring technology, interactive TV program guides, steam turbine technology and medical devices. Tom has also represented clients in counseling matters regarding various computer software and hardware patents, including patents relating to modems, DRAM technology and computer graphics. Tom is a contributing author of the Patent Trial Advocacy Casebook, published by the American Bar Association and the National Institute for Trial Advocacy. Tom has also served on Banner Witcoff's Board of Directors, and has also served as President of the firm.
